

#### ACNC UPDATE ON ATSIHQ APPLICATION



## THOUSANDS OF HOMES TO BE DELIVERED IN SOCIAL AND AFFORDABLE HOUSING

HE Palaszczuk Government is forging ahead with plans to deliver more than 7000 new social and affordable homes for Queenslanders over the next four

The Premier today announced the government had released Expressions of Interest for the Queensland Housing Investment Growth Initiative (QHIGI).

The Palaszczuk Government is investing \$2.9 billion, including \$1 billion to establish a Housing Investment Fund, to support better long-term housing outcomes for vulnerable Queenslanders.

Treasurer and Minister for Trade and Investment Cameron Dick urged the property and housing sectors to come forward with projects to increase social housing and affordable housing across Queensland.

Minister for Communities and Housing Leeanne Enoch said the release of the Housing Investment Fund EOI was just one component of the Queensland Housing Investment Growth Initiative, a coordinated capital investment program to increase the social housing portfolio by more than 7000 new homes over four years.

Minister for Youth Affairs and Member for Gaven Meaghan Scanlon said the youth foyer would provide critical support to young people to help transition towards independent living.

EGISLATION to make renting fairer has passed Queensland's Parliament in October. Minister for Communities and Housing renters.' Leeanne Enoch said the new laws would end 'without grounds' evictions and make it easier for Queensland renters to keep a pet.

The new laws will also ensure all Queensland rental properties meet minimum quality standards and extend protections for renters who have experienced domestic and family violence.

"At a time when Queenslanders are renting, and renting for longer, the Palaszczuk Government is encouraging market growth to help increase the

number of rental properties in Queensland, while protecting the rights of

Minister Enoch said some of the proposed renting reforms, such as the domestic and family violence measure, were tested during the COVID-19 pandemic.

"This provision ensures people fleeing domestic and family violence are able to end a lease with seven days' notice or change locks in a rental property without the owner's consent to ensure their safety," Ms Enoch said.

EADERS representing the 22 councils of Western Queensland, covering 60% of the State, have released a first region-wide Housing Market Study today. The Study reveals the region's chronic shortage of housing - a major roadblock to community, employment and business growth that is only set to worsen.

## **QUEENSLAND** WOMEN URGED TO GET **VACCINATED** TO PROTECT THEMSELVES

While speaking at the Micah Projects Women's Safety, Security + Stable Housing Forum in October, Minister for Communities and Housing Leeanne Enoch called on women to roll up their sleeves and get the jab.

"The safety and wellbeing of women is so important, particularly as we tackle the issue of domestic and family violence in our communities," Ms Enoch said.

"Getting the COVID-19 vaccination is one of the ways women can protect themselves and ensure their health and the health of their

The Micah Projects Women's Safety, Security + Stable Housing Forum brought together women, service providers and representatives from government and community organisations to hear ideas and solutions for progressing women's safety, security and stable housing in our community.

Ms Enoch told the forum that the Queensland Government has placed a strong emphasis on housing in its response to domestic and family violence.

## SMOKEALARM DEADLINE LOOMS



\*HE Fire and Emergency Services (Domestic Smoke Alarms) Amendment Act 2016 (Qld) commenced on 1 January 2017 and imposes additional obligations on property owners/managers with regards to the installation and maintenance of smoke alarms at domestic dwellings.

All ICHO's, property owners and

managers are reminded that the deadline of

- 1 January 2022 looms for smoke alarms to: • be photoelectric (AS 3786-2014); and
  - not also contain an ionisation sensor; and
  - be less than 10 years old; and
  - operate when tested; and

- be interconnected with every other smoke alarm in the dwelling so all activate together; and
- be either hardwired or powered by a non-removable 10-year

Smoke alarms must be installed on each storey:

- in each bedroom; and
- in hallways which connect bedrooms and the rest of the dwelling;
- if there is no hallway, between the bedrooms and other parts of
- if there are no bedrooms on a storey, at least one smoke alarm must be installed in the most likely path of travel to exit the

# MATIVE TITLE for KOA



ESTERN Queensland's Koa people have had their identity strengthened following a Federal Court deci-

Koa Traditional Owner Pamela Hegarty said the native title determination of nearly 865,000 hectares of land and waters near Winton would help provide justice for her ancestors.

"Holistically, this will strengthen Koa people to move forward not only on country but for the very essence of their Koa identity," Ms Hegarty said.

"It will diminish myths about Koa people and rectify misconstrued thoughts and opinions once and for all about Koa traditional land ownership of country in its entirety."

Resources Minister Scott Stewart congratulated the Koa people on their historic determination.

"Today's is a momentous day for the Koa people as the Federal Court recognises what they have always known about their connection to their land," Mr Stewart said.

Aboriginal and Torres Strait Islander Partnerships Minister Craig Crawford said the determination recognises the rights and interests over 864,988 hectares of land and water between Corfield, Winton and Kynuna.



\$12 MILLION FOR ABORIGINAL HOMELESSNESS SERVICES IN NSW

BORIGINAL people experiencing homelessness or at risk of homelessness will receive better support under a \$12 million NSW Government plan to boost the capacity of Aboriginal Controlled Community Organisations (ACCOs).

Minister for Families, Communities and Disability Services Alister Henskens said the Aboriginal Homelessness Sector Growth project will lead to more ACCOs delivering quality services and support to vulnerable people.

"We will consult with Aboriginal communities and partner organisations in these areas to identify local priorities and co-design service delivery models that meet local needs."

Priority groups for the initiative include Aboriginal people experiencing street sleeping, Aboriginal women and children that have experienced domestic and family violence, and young Aboriginal people who are experiencing or at risk of homelessness.

The project follows the success of the Aboriginal-led Together Home project on the Central Coast which is helping 17 people off the streets and into secure housing with wrap-around support to address their individual needs.

# SOUTH AUSTRALIAN HUB TO BE SET UP FOR ABORIGINAL ROUGH SLEEPERS

he South Australian Government will set up a temporary hub with showers, toilets, tents and offices in the southern park lands to accommodate and provide support to about 50 people from remote Aboriginal communities who are sleeping rough.

The hub is described by the Department for Human Services as a "state-first" response to supporting Aboriginal people who travel from remote communities to Adelaide for various reasons, including to seek medical services, attend court or visit family.

Called "Puti on Kaurna Yerta", or Bush in the City, the hub will be patrolled 24/7 by security officers and staffed by representatives from SA Police, SA Health, the Department for Human Services, Aboriginal Affairs and Reconciliation, SA Housing Authority, Attorney-General's Department and Adelaide City Council, as well as several non-government organisations.

People who visit the hub will have access to a range of services, including drug and alcohol, medical, mental health and legal support, which will be offered between 7am to 11pm from the privacy of mobile offices.

ICTORIA is launching a \$500 million fund to get homebuyers into the market, in exchange for a share in the property.

The fund is an expansion of the \$50 million HomesVic Shared Equity Initiative, which the government said helped more than 330 households into the market.

Under the plan, would-be homeowners need to have a 5 per cent deposit, with the government able to kick in up to 25 per cent of the value of the home.

They do not need to be first homebuyers, but cannot currently own a property.

"They'll be able to buy homes with the help of the Victorian government, which will be an equity partner in the purchase," Mr Pallas said.

Aboriginal and Torres Strait Islander Victorians will be able to apply for the fund with only a 3.5 per cent deposit.




## 30 YEARS AGO (OCTOBER 1991) THE MONTH-LONG PERJURY TRIAL of former National
